Recent announcements by the state government of the addition of new Policy Safety Officers will not address the challenges we are facing.



## WE NEED A REX-PLANATION!

The recent reductions in flight services to Ceduna by REX Airlines are an extremely disappointing development for residents of the Far West.

Although REX has declared they will continue to provide reduced services to Ceduna, their decision to cease services into Whyalla is of great concern to residents of the Eastern Eyre, particularly in Cowell and Kimba, who rely on Whyalla Airport services to travel to Adelaide, as well as their decision to reduce flights into Port Lincoln impacting those on the southern EP.

I have been working with my federal colleague, Rowan Ramsey, and my state colleagues to seek an explanation from REX Airlines as to when these services will be restored.

To date, we are yet to receive any firm date as to when these services will be restored.

I will continue to lobby REX to return these vital services to the Eyre Peninsula and remind those who make these decisions that, for residents of the EP, flight services are less about tourism and more about health and education.

There's no use trying to create more jobs if parents don't have access to childcare, and I will keep looking at every option



## **OUR JETTIES DESERVE BETTER** There are 35 jetties across South

Australia which are operated and managed by councils and in dire need of investment on behalf of a state Labor government keen to pass the buck.

The small amount of funding in the recent state budget is barely a drop in the bucket given Tumby Bay jetty, alone, will require four million dollars worth of repair work to be brought up to standard. This city centric government clearly does not understand the importance of jetties to our regional economies, particularly at the height of tourism season, when visitors flock to our regions to enjoy the simple pleasures in life, such as fishing and swimming. I will continue to work with our local councils to find the funds needed to bring our jetties up to scratch,

I recently spoke again with the CEO of the Department about my ongoing concerns regarding the quality of work which has been delivered, and the time it has taken while the community continues to be affected. I sought reassurance that there was some positive action happening and that the community be informed of what the plan is.

I impressed on him the reason that the work was failing was because of the poor workmanship, and the need for there to be an appropriate hot-mix surface put in. I have also been regularly seeking assurance from the Minister that the extra time and work which has been undertaken hasn't been at the cost of the taxpayer, and the Minister has on multiple occasions assured me that the contractors have been the ones who have been footing the bill.

Interestingly, there was an recent advertisement in the local papers from PW2PA, the head contractor. They were apologising to the public about the time and workmanship, and I hope it is a sign that they are going to finally do a proper job, and get it done as soon as possible.

I will continue to be pushing them until this happens!
